The Established Contractor shall be registered in CIDB contractor grading designation **6CE or higher**.

Failure to attend the compulsory briefing meeting will result in the tenderer's bid being rejected or disqualified. Tenderer(s) will be required to subcontract a minimum of 10% of the value of contract to the Targeted Enterprise.

Only bidders who score **70 points** on functionality criteria will qualify for the second stage of evaluation.
