The Established Contractor shall be registered in CIDB contractor grading designation **7CE or higher**.

A compulsory briefing session and site visit will be held on **Thursday, 30 March 2023 at 10H00, at Dumaphansi Secondary School in Msinga (Coordinates 28°49'37.79" S, 30°23'37.98" E)**. Failure to attend the compulsory briefing meeting will result in the tenderer's bid being rejected or disqualified. Locally produced or manufactured goods, meeting the stipulated minimum thresholds for local production and content for all Designated Sectors in the Declaration Certificate (MBD6.2) will be considered.

Tenderer(s) will be required to subcontract a minimum of 25% of the value of contract to the Targeted Enterprise.

Only bidders who score **70 points** on functionality criteria will qualify for the second stage of evaluation.
