Locally produced or manufactured goods, meeting the stipulated minimum thresholds for local production and content for all Designated Sectors in the Declaration Certificate (MBD6.2) will be considered.

Tenderer(s) will be required to subcontract a minimum of 20% of the value of contract to the Targeted Enterprise.

The completed tender documents complying with all conditions of the tender must be enclosed in a sealed envelope and clearly marked with the relevant "**BID NUMBER**" must be deposited in the official tender box located at the reception area, Princess Magogo Building, 39 Victoria Street, Dundee 3000, no later than closing date **18 April 2023, Tuesday, at 12H00** which will be followed by an opening. Late bids or bids received by way of post, facsimile or e-mail will, under no circumstances be considered.

Tenders will be evaluated on the Functionality Criteria as specified in the tender documents and thereafter bidders who score a minimum required number of points will be further evaluated using the 80/20 or 90/10 Preferential Point System as prescribed in the Council Supply Chain Management Policy. Only bidders who score **70 points** on functionality criteria will qualify for the second stage of evaluation.
