Request for Quotations for the creation of GIS based, economic sector maps, for Endumeni Local Municipality and Selected District Wide Catalytic Projects

Only bidders that have the required and necessary experience and knowledge of GIS Mapping are eligible to submit quotations.

As part of the Endumeni Local Municipality – LED Review - for the 2021/2022 financial year, the Umzinyathi Development Agency which is the entity of Umzinyathi District Municipality requires GIS based spatial representation of the key economic sectors within the area. The appointed service provider will be required to:

1. Review and update (using GIS) the spatial development trends within the area,
2. To identify and spatially represent economic sector trends and potential growth areas within the local Municipal Area.
3. To map key linkages and areas of opportunities within the wider UMzinyathi District.

In addition, you will be required to provide the following base maps:

- I. Contextually locating the Municipality within the wider District.
- II. Map primary sector activities focusing on agricultural land and mining.
- III. Map secondary sector activities focusing on manufacturing.
- IV. Tertiary sector maps that focus on tourism, business development and economic development must also be included.
- V. A series of infrastructure maps that demonstrate the current infrastructure availability and planned upgrades must also be included.
- VI. Key catalytic projects identified within the current SDF must be mapped.
